DIRECTIONS: From Rt. 50 East or West To Rt. 2/Governor Ritchie Hwy N: Turn left at Cypress Creek (Stop light), 1-1/2 blocks to Summit, turn right, to 1st stop sign. Turn left at stop sign, then left again in 1/2 block to Severna Park Community Center parking lot (marked with sign at entrance). Also park in Woods Memorial Presbyterian Church parking lot, walk down using stairs or driveway.
